How to get your permit:

1. Read the conditions of entry and cancellation policy overleaf.
2. Complete this form and return via email to ranger@steepoint.com.au or fax to (08) 9948 3963
3. Within 48 hours of sending the form ring the ranger on **(08) 9948 3993** to pay your fees **in full** via credit card (Ranger hours are 9am – 4pm, seven days a week).
4. A receipt will be returned to you by email or fax.
5. Ring the ranger two days before you arrive to confirm numbers. Bring receipt with you as proof of payment.

Fees and Payment

- An entry fee applies to all vehicles except for Parks and Wildlife Park Pass holders* and camping fees apply for overnight stays.
- Payment is by credit card over the phone (VISA or Mastercard).
- A cancellation fee of \$25 applies. See page overleaf for details.

Conditions of Entry | Steep Point and Edel Land



For Your Safety

- Be prepared for the heat. Take at least 10 litres of water for each person per day.
- Exercise extreme caution near cliff edges. This is a dangerous coastline with large surf, 200 metre high cliffs with unstable edges and blowholes.
- Wear a life vest if fishing from cliffs. A limited number of life vests are available for hire - ask the ranger.
- Supervise children at all times.
- Let someone know where you are going and when you will be back.

Entrance and Camping Fees

- Please display your camping permit on your vehicle dashboard where it can be easily read.

Four-wheel-driving Code

- Drive carefully and to the conditions.
- High clearance 4WD is required for the soft, sandy tracks. See 'Four wheel driving in Shark Bay'.
- All vehicles must be registered for road use. Unregistered off road vehicles are not permitted.
- Normal road traffic rules apply. Seat belts must be worn. Riding the back of utilities and drink driving are prohibited.
- Reduce your tyre pressure to negotiate the soft sand tracks. We suggest a tyre pressure of 20psi (trailers included) as a starting point. The pressure will vary according to vehicle type and load as well as type of tyre and rim.
- Drive only on existing vehicle tracks, with tyre pressure reduced and 4WD engaged at all times.
- Entry to the Useless Loop area is not permitted.

For the Environment

- Firearms, weapons and fireworks are not permitted.
- Pets are prohibited (except guide dogs) to protect native wildlife and prevent poisoning of pets by 1080 baits laid to control foxes and feral cats.
- All native wildlife is protected. Leave plants, animals, rocks, shells and soils as you find them.
- Don't bring seeds and non-native plant material into the area to help prevent the spread of weeds.

Camping Code

- Fires are not permitted. Please use your portable gas barbecue.
- To assist with waste management please take out what you bring in.
- Stow rubbish securely to prevent it from being blown away. Keep your campsite clean to prevent animals from scavenging.
- Basic toilets are provided at Steep Point and Shelter Bay. Outside of these areas bury human waste in a 500mm deep hole at least 100m away from public areas or the coastline. Please do not empty chemicals into toilets as this will kill the bacteria which help to break down human waste within the system.

When Fishing

- Abide by Department of Fisheries regulations at all times. Know your bag limits and fish for the future.
- No fishing is permitted in sanctuary zones including the Surf Point Sanctuary Zone opposite Steep Point.

CANCELLATION POLICY

Campers who change or cancel proposed camping at short notice effectively limit or prevent others from using the camping facilities. The Department of Parks and Wildlife reserves the right to offer alternative camping arrangements for any reason beyond our control.

Changes to a booking

- You are permitted to alter your camping arrangements at no charge - availability permitting.
- If you wish to change your booking after full payment is made you will either pay, or be refunded, the difference depending on the change you make. Note that space at camp sites is limited and there may not be room for extra people or vehicles.
- In cases where the access road is closed due to inclement weather and your stay is shortened, you will be refunded the unused portion of your stay.

Cancellation of a booking

- A non-refundable cancellation fee of \$25 applies.
- If you cancel your booking after paying all fees you will be refunded your payment MINUS the cancellation fee of \$25. You must provide the original receipt to claim this refund.
- In cases where the cancellation fee is more than the total amount paid you are not entitled to a refund.
- Parks and Wildlife will not give refunds based on circumstances outside of its control eg. a decision to change plans, poor weather and / or ill-health not of a life threatening nature.
- In circumstances of serious injury to you, other camping members or your immediate family (medical certificate required) refunds may be given. Applications must be in writing and include details of the injury / illness and include a copy of the medical certificate. Privacy Policy
